Global Quality P4P PCP Program

Description:

 The IEHP Global Quality P4P PCP Program is for high performance and year-over-year improvement in key quality performance measures.

Provider Eligibility:

- Must be active and contracted with IEHP for Medi-Cal and have active assigned Medi-Cal Members at the time of payment.
- PCPs must have a signed Incentive Program contract amendment prior to the start of the 2026 Global Quality P4P PCP Program performance period in order to be eligible to receive incentive dollars.
- Have at least 200 Medi-Cal Members (per Provider location), assigned as of July 2026 and December 2026.
- Have at least 20 Members in the denominator as of December 2026 for each quality measure to qualify for scoring.
- Quality Score must be 1.0 or higher in order to qualify for incentive payments.
- Have at least three quality measures that meet minimum denominator requirements in order for a global quality score to be calculated.
- Provider must be connected to CAIR2 (must enter immunizations into the registry and use to look up prior immunizations given to assigned patients) by July 1, 2026.

OB P4P Program

Description:

 The OB P4P Program provides an opportunity for OB providers to earn a financial reward for improving the quality of maternity care for IEHP's pregnant and postpartum members.

Provider Eligibility:

- Providers active, credentialed, and contracted with IEHP for Medi-Cal and Covered California that provide obstetrical services
- Must have a signed Incentive Program contract amendment prior to the start of the 2026 OB P4P Program performance period

IEHP Direct Stars Incentive Program

Description:

 The IEHP Direct Stars Incentive Program is designed to reward IEHP Direct PCPs for high-quality care provided to IEHP's Direct DualChoice (D-SNP) members.

Provider Eligibility:

- Must be active and contracted with IEHP for D-SNP and have active assigned IEHP Direct D-SNP Members at the time of payment.
- PCPs must have a signed Incentive Program contract amendment prior to the start of the 2026 IEHP Direct Stars Incentive Program performance period in order to be eligible to receive incentive dollars.
- PCPs, Federally Qualified Health Centers (FQHCs), Indian Health Facilitates (IHFs) and Rural Health Clinics (RHCs) must have an IEHP Direct D-SNP contract with IEHP.
- Have at least 30 IEHP Direct D-SNP Members (per Provider location) assigned as of December 2026.
- Have at least 10 IEHP Direct D-SNP Members in the denominator as of December 2026 for each measure to qualify for scoring.
- Have at least three measures meet the minimum denominator requirement to calculate a star rating.
- Must have an average assigned Membership risk adjustment factor score of 1.0 or higher.

Urgent Care + Wellness Quality Incentive Program

Description:

 The Urgent Care + Wellness Quality Incentive Program has been designed to reward urgent care providers for improving wellness services for IEHP Medi-Cal and Covered California Members.

Provider Eligibility:

- Urgent Care Provider that is active and contracted with IEHP for Medi-Cal, and has at least one PCP-type practitioner
- Urgent Care Providers must have a signed Incentive Program contract amendment prior to the start of the 2026 Urgent Care + Wellness Quality Incentive Program performance period
