Our annual Standing Orders Program has been recognized as a best practice for reaching out to IEHP Members aged 50-74 years who are due for a recommended mammogram. **IEHP's standing orders are evergreen and enrollment is easy.**

PLEASE NOTE

IEHP Direct opt-in includes ALL product lines: Medi-Cal, IEHP Covered (CCA), and Medicare/DSNP.
IEHP Delegated (IPA affiliated PCPs) opt-in includes Medi-Cal only

Upon enrollment in the breast cancer screening standing orders program, **you consent to allow IEHP to outreach to all your assigned IEHP Members that are due for this screening. The 2025 program outreach will include Members aged 50-74 years who are due for a recommended mammography screening before the end of the year.**

Qualifying Members are listed on your Performance Breast Cancer Screening Member Rosters located on IEHP's Provider Portal under the Global Quality P4P PCP Reports. Members with a standing order will be instructed to contact a nearby RadNet facility to schedule their mammography screening appointment. **All screening results will be routed to your office for review and follow up.**

Your participation in this program is vital in helping IEHP Members achieve optimal health and receive their recommended preventive health services in a timely manner. **Please complete the attached IEHP Standing Order Enrollment Form today, indicating your desire to enroll in this important program.**

Complete the two (2) steps below and return to IEHP by May 09, 2025.

Selecting ‘Yes’ indicates your approval for IEHP to provide the order to a contracted radiology facility for a Breast Cancer Screening on your behalf and continuous participation in the Standing Orders Program for subsequent years. This order will be provided for your IEHP Members identified as needing a mammography screening.

Electing **not** to participate indicates that you will order the screening listed below for your IEHP Members identified as needing specific health service to meet measure criteria before the end of the measurement year. Additionally, you will order these screenings for future IEHP Members in your panel and provide encounter data back to IEHP timely.
