We have made the following updates to the 2025 Global Quality (GQ) P4P PCP Program Guide:

MEASURE UPDATES

Adult Zoster Vaccine	Language updated in measure numerator criteria: Members who received two doses of the herpes zoster recombinant vaccine (at least 28 days apart), on October 20, 2017, through the end of the measurement year (2025).		
Adult Pneumococcal Vaccine	 Added code to pneumococcal vaccine numerator: 90684 		
Asthma Medication Ratio	Removed the following medication list from Asthma Reliever Medications: Albuterol budesonide		
Breast Cancer Screening	 Measure description has been updated, expanding the age range to 40-74 years of age. 		
Cervical Cancer Screening	 Removed code from codes to identify cervical cytology: Q0091 Added code to identify HPV test: 0502U 		
Childhood Immunization – Combo 10	 Removed code from flu vaccine antigen: 90673 Added code to flu vaccine antigen: 90658 Added an exclusion to the measure description: Members who had an Organ and Bone Marrow Transplant. 		
Colorectal Cancer Screening	Added code to colorectal screening numerator: 0464U		
Weight Assessment and Counseling for Nutritional and Physical Activity for Children and Adolescents - BMI	Added codes to the BMI percentile numerator: Z68.55 and Z68.56		
Statin Therapy Received for Patients with Cardiovascular Disease	Updated Lovastatin prescription to 40 – 60mg for moderate-intensity statin therapy.		
Statin Therapy Received for Patients with Diabetes	 Updated Lovastatin prescription to 40 – 60mg for moderate-intensity statin therapy. 		
Developmental Screening	Added the following acceptable modifiers: SA, GN, GO, GP, GQ, GT, U9, 59, XE, XS, XP, XU, and EP.

CODE REQUIREMENT CLARIFICATION

• The codes listed below were added to the program guide on 5/16/2025. This is a clarification regarding the code requirements. Codes Z76.1 and Z76.2 are not mandatory to use in the P4P program. However, the codes are optional as additional numerator opportunities for the measures listed below. If codes Z76.1 and Z76.2 are selected, the codes must be billed as the Primary diagnosis on the encounter for the encounter to process correctly.

QUALITY BONUS SERVICES (QBS)

IEHP is pleased to introduce the following two new services to the Quality Bonus Services for the 2025 Global Quality P4P program:

- 3 Month Supply Asthma Prescription Conversion (\$25*)
- Symbicort Initiation for Persistent Asthma (\$25*)

*NOTE: The 3-Month Supply Asthma Prescription Conversion and Symbicort Initiation for Persistent Asthma services will <u>not</u> be included in the Quality Bonus Services monthly payment schedule. IEHP will issue a lump-sum payment for the 3-Month Supply Asthma Prescription Conversion and Symbicort Initiation for Persistent Asthma services to qualified Providers, April 2026.

QBS Eligibility and Participation

- Updated Eligibility and Participation for Global Quality P4P Quality Bonus Services:
 - To be eligible for Quality Bonus Services, Providers must be contracted with IEHP as a Medi-Cal Primary Care Physician (PCP) participating in the 2025 Global Quality P4P Program.
 - **NOTE**: Federally Qualified Health Centers (FQHCs), Indian Health Facilities (IHFs), and Rural Health Clinics (RHCs) are **only** eligible for the following Quality Bonus Services:
 - 3 Monthly Supply Asthma Prescription Conversion
 - Symbicort Initiation for Persistent Asthma
