Inland Empire Health Plan (IEHP) has made the following updates to the 2025 IEHP Direct Stars Incentive Program:

PROGRAM ELIGIBILITY

- Providers' minimum membership assignment for program participation eligibility extended:
 - o Providers are required to have at least 30 IEHP Direct D-SNP Members assigned **as of December 2025**.

MEASURE UPDATES

- IEHP is pleased to introduce the following **NEW** core measure to the 2025 IEHP Direct Stars program:
 - o Diabetes Care – Kidney Health Evaluation

The Quality Bonus Services offer incentive dollars that Providers can earn in addition to the 2025 IEHP Direct Stars Quality PMPM earnings. The 2025 IEHP Direct Stars Program has added the Quality Bonus Services listed below:

Quality Bonus Services Provider Eligibility:

- Providers must be contracted with IEHP as a Direct D-SNP Primary Care Physician (PCP).
 - o **NOTE:** Federally Qualified Health Centers (FQHCs), Indian Health Facilities (IHF) and Rural Health Clinics (RHCs) are only eligible for selected Quality Bonus Services:
 - Statin Initiation for Diabetes or Cardiovascular Disease
 - 3-Month Supply Prescription Conversion
