In addition, IEHP identified issues with the Laotian section of the **Notice of Availability (NOA) - D-SNP Letter Template** concerning the text characters. For this reason, the document was revised and reposted for the **D-SNP line of business**. The necessary changes were made to align with Department of Health Care Services (DHCS) standards.
