NEW ELIGIBILITY AND PARTICIPATION REQUIREMENT

 OB Providers must have a signed Incentive Program contract amendment prior to the start of the 2026 OB P4P Program performance period to be eligible to receive incentive dollars.

IMPORTANT: Provider Incentive Amendments must be signed and returned to IEHP by <u>December 15, 2025</u>, to participate in the 2026 OB P4P Program.

GENERAL PROGRAM INFORMATION

Payment Schedule

- 2026 OB P4P Program incentives will be paid by IEHP on the 20th of each month.
- The payment schedule is published in the 2026 OB P4P Program Guide.

Reporting Services via Standard Claims Process

- Submit claims with valid incentive codes to your IPA within 60 days of the service.
 - No additional action is required to receive eligible incentive payment(s) from IEHP.
- Your IPA will report all claims to IEHP through the encounter reporting process, and IEHP will pay the eligible P4P payments.
- Eligible OB Providers will receive incentive payments through Electronic Fund Transfer (EFT) or a mailed check from IEHP.
