New Eligibility and Participation Requirement:

- Primary Care Physicians (PCPs) must have a signed Incentive Program contract amendment prior to the start of the 2026 Global Quality P4P PCP program performance period, to be eligible to receive incentive dollars.

New Measures:

- **Core Measures**
 - Screening for Clinical Depression in Primary Care
 - Social Determinant of Health Identification Rate
 - Social Determinants of Health Screening Rate – Monitor Only
 - Social Needs Screening and Intervention – Monitor Only
 - Substance Use Assessment in Primary Care
 - Substance Use Assessment in Primary Care for Adolescents

Retired Measures:

- Core Measures
 - Asthma Medication Ratio
- Quality Bonus Service:
 - 3 Month Supply Asthma Prescription Conversion
 - Symbicort Initiation for Persistent Asthma

Payment Methodology:

- Added a Quality Star Rating to reference the Quality Score
