New Eligibility and Participation Requirement

 Urgent Care Providers must have a signed Incentive Program contract amendment prior to the start of the 2026 Urgent Care + Wellness Incentive Program performance period, in order to be eligible to receive incentive dollars.

GENERAL PROGRAM INFORMATION

Eligibility

 Urgent Care Provider that is active and contracted with IEHP for Medi-Cal and has at least one Primary Care Physician (PCP) type practitioner.

Services

 The following services are included in the 2026 Urgent Care + Wellness Quality Incentive Program:

Adolescent Immunizations

- Fluoride Varnish
- Child and Adolescent Well-Care Visits
- o Lead Screening

Payment

- Eligible Urgent Care providers will receive a monthly financial incentive for each eligible service. Service must meet the eligibility criteria as stated in the program guide.
- 2026 Urgent Care + Wellness Quality Incentive Program incentives will be paid monthly by IEHP, on the 20th of each month.
- Participating Urgent Care Providers will be reimbursed for eligible adolescent immunizations for the measurement year 2026. NOTE: The reimbursement amounts also include adolescent immunization administration. The following adolescent immunizations qualify for reimbursement:
 - Meningococcal Conjugate
 - Tdap (Tetanus-Diphtheria-Pertussis)
 - Human Papillomavirus (HPV)
