**Subject: IEHP Urgent Care Telehealth Services Available to Members!** 

To support our member's access to all avenues of care available, including virtual options, IEHP is engaging in an awareness campaign with our members. IEHP is partnered with MDLive. MDLive offers virtual urgent care services available 24 hours a day, 7 days a week, 365 days a year through both phone and video. Available services include assessment, evaluation, treatment, advice, and prescriptions provided to Members or their family members.

IEHP continues to promote and encourage members to engage and maintain a strong relationship with their Primary Care Provider and other care team members. If you are unable to set up a timely appointment in person or virtually, and you feel it is appropriate, you can refer the Member to **IEHP's virtual urgent care service** for quick access to a Board-Certified Physician.

## Conditions not appropriate for MDLive visits:

- o Emergency situations (broken bones, significant bleeding, heart attack)
- o Behavioral Health Conditions
- o Internationally located patients
- o Sexually transmitted diseases prescription refills are available for some conditions
- o Urinary tract infections in males of all ages
- o Urinary tract infections in females under 18 years of age
