**Subject:** **2026 Global Quality P4P Program – Manifest MedEx (MX) Connectivity Reminder**

Inland Empire Health Plan (IEHP) would like to remind you of the 2026 Global Quality P4P (GQ P4P) measure requirements for Manifest MedEx (MX) Connectivity.

This is the fifth year of the Manifest MX Connectivity measure. We encourage providers to participate in Manifest MX to help IEHP increase PCP connections and improve data quality, patient care, and coordination.

The five (5) milestones included in the 2026 MX Connectivity measure are:

**For PCPs without an established MX Connection\*:**

- **Milestone 1:** Get Connected to Manifest MedEx!

**For PCPs with an established MX Connection\*:**

- **Milestone 2:** Stay Connected to MX
- **Milestone 3:** Improve Data Quality - Reporting Minimum Data Requirements
- **Milestone 4:** Improve Data Quality - Reporting Clinical Data Elements
- **Milestone 5:** Improve Data Quality - Behavioral Health Data Elements

**Meeting selected milestones will add additional PMPM to your overall GQ P4P Quality PMPM rate!\***

- Milestone 1: This Milestone is monitoring only.  
Note: Providers must be connected to MX to be eligible for the Milestones 2-4 incentive.
- **Milestones 2- 4: Providers can earn an additional \$0.25 Quality PMPM per eligible Milestone.**
- Milestone 5: Monitoring only.

*\*Providers eligible for milestone 1 cannot participate in milestones 2-5, cited above, for the 2026 performance year. Providers who established their MX connection in 2022, 2023, 2024, or 2025 performance years are eligible for milestones 2-5. Provider must document all data elements in the Electronic Medical Record (EMR). Documents scanned into the chart will not count as compliant for this measure.*

## **Signing Up with Manifest MedEx:**

**Providers who have not established a connection with Manifest MX will need to get connected in the 2026 performance year to qualify for paid Milestones in the 2027 performance year. Please see below for connectivity details.**

### **Manifest MedEx Connectivity**



#### **Measure Description:**

Providers are encouraged to continue utilizing the Manifest MedEx (MX) Connectivity platform to help improve data quality efforts.



#### **Measure Requirements:**

1. **Have and maintain connection to MX**
2. Routine reporting of required data by **December 31, 2026**
