Subject: **Prop 56 and GEMT Updated Payment Schedule**

The Prop 56 and Ground Emergency Medical Transportation (GEMT) payment schedule has been updated.

What Is Changing?

Prop 56 and GEMT payments, which are currently issued on a staggered schedule, will be **consolidated into one payment date during the third week of each month.**

Previously:

- The first payment, including **GEMT, HYDE, and Developmental Screening**, was issued during the third week of the month.
- The second payment, including **PP-GEMT, Trauma Screening, and Family PACT**, was issued the following week.

Programs Impacted

The updated payment schedule applies to the following programs:

- **Prop 56:** HYDE, Developmental Screening, Trauma Screening, and Family PACT
- **GEMT:** GEMT and PP-GEMT

What Providers Need to Know

There are **no changes to provider reimbursement, billing, or payment amounts** as a result of this update. The change only consolidates the timing of the applicable payments.

No action is required from providers. Providers should use the updated payment schedule as a reference for future Prop 56 and GEMT payments.
