Introducing **IEHP COVERED**

Inland Empire residents looking for health insurance through Covered California will see a trusted name on the list – Inland Empire Health Plan (IEHP).

IEHP Covered is now available on the exchange, with the lowest cost silver plan in the Inland Empire, for those seeking coverage in 2024. Open enrollment runs from Nov. 1 to Jan. 31, 2024. Additionally, if a qualifying life event occurs, IEHP Covered is available outside of the open enrollment period.

"IEHP will be only the second public managed care plan to go into the exchange," said IEHP Chief Executive Officer Jarrod McNaughton. "Joining Covered California is an important step to ensuring our Members and others in the community can continue to access the quality health care services they need."

IEHP has estimated that every year, approximately 15,000 to 20,000 members in Riverside and San Bernardino counties may lose their Medi-Cal coverage due to increased income reported during the redetermination process.

Covered California is the only place Californians can go to receive financial help to make their coverage more

affordable. Right now, 90% of Covered California's 1.6 million enrollees receive financial help, with many people paying \$10 or less per month for their health insurance. Based on pre-pandemic trends, nearly half of the consumers who transition from Medi-Cal to Covered California will be able to get quality coverage at little to no cost.

Known as the plan with a heart, IEHP is one of the top 10 largest Medicaid health plans and the largest not-for-profit Medicare-Medicaid public health plan in the country. Now IEHP will be able to extend our services to consumers in the Covered California market who could not previously enjoy the benefits of being an IEHP Member.

Are you interested in being an IEHP Covered provider? Providers interested in being a part of the IEHP Covered network can reach out to contract@iehp.org. Please be aware that there are specific quality criteria that providers must meet to be offered an IEHP Covered contract. This may limit some providers from participating.

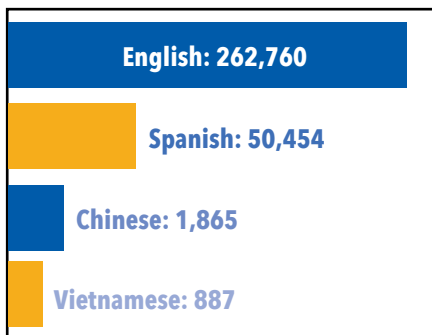

Member Languages

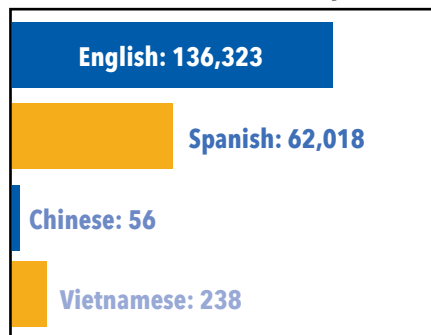
BY REGION

REDETERMINATION

Ensuring Members Maintain Coverage

When the Public Health Emergency ended in May 2023, California counties began to review whether Medi-Cal beneficiaries still qualified for coverage. As these Medi-Cal redeterminations commenced, disenrollments started to occur on July 1, 2023.

Since then, IEHP has lost an average of 19,000 members per month. October 2023 had the highest number of disenrollments, with 28,000 Members disenrolled from IEHP. The main contributor to these disenrollments: IEHP Members did not complete their redetermination forms on time.

Please talk to your patients about submitting their Medi-Cal redetermination applications to the county Medi-Cal offices on time. When Medi-Cal redetermination applications are submitted on time, eligibility will hold – pending the processing of the renewal.

Here are several ways you can help:

- If you see a Medi-Cal redetermination alert, on the IEHP Provider Portal, ask the Member if they received their yellow redetermination packet in the mail.
- If a Member has not received their yellow redetermination packet, instruct them to contact their county Medi-Cal office to update their address information and request their packet.

- Inform Members they can renew their Medi-Cal coverage in person, by phone, by mail, or online at www.BenefitsCal.com by selecting the “Create an Account” link.
- **Inform Members that they can receive assistance by contacting IEHP’s Eligibility Support Team at 1-888-860-1296, Monday through Friday, 8 a.m. to 5 p.m. IEHP is here to help!**

Thank you for helping our Members keep IEHP coverage and receive needed care.

ENROLLMENT

Baby coverage from day 1

Samantha B. was well-prepared for her baby's arrival, stocking up on essentials such as clothing, diapers, and blankets. However, she was taken aback by the need to get health insurance for her newborn son, Myles.

"I wasn't aware that after your baby is born that you do have to get insurance for them," said Samantha, an Inland Empire Health Plan (IEHP) Member and daughter of a Team Member. "It's something to worry about."

One of the main reasons for a gap in care for children ages 0-2 years old is the failure to enroll newborns into a health plan right after birth.

IEHP partnered with the Women's Center at Pomona Valley Hospital Medical Center (PVHMC) to address this issue. PVHMC's admitting representatives present each expectant mother with a "Welcome Baby" letter upon check-in, which enrolls the baby for ongoing Medi-Cal coverage.

"During the time when Mom is getting ready to bring in a new addition to the family, there are so many things running through her mind," said Nichelle Ford,

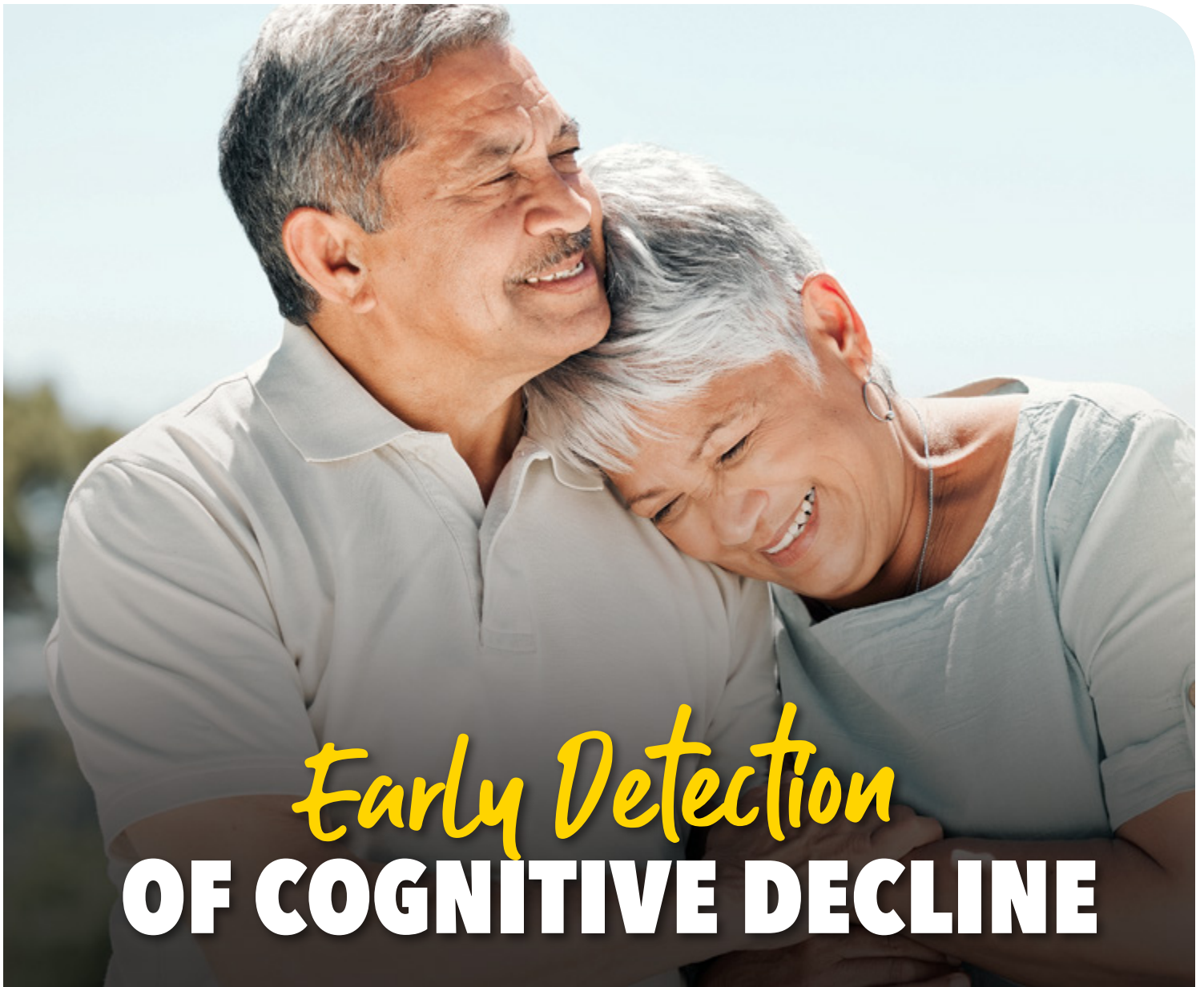
patient access manager at PVHMC. "So, Pomona Valley just wants the mom to know we are here for them and with the newborn enrollment process, that baby is covered before Mommy leaves the hospital."

Thanks to the power of partnership, the process of signing up newborns for health insurance from Day 1 is becoming more streamlined, ensuring timely health coverage for newborns.

"What we really hope to do with this partnership is to help our moms and our new families have the support they need to know who that baby's primary care provider is, who their pediatrician is going to be to care for them, and know where to call if they need help," said Genia Fick, IEHP's Vice President of Quality.

IEHP is excited to share that our partnerships to support newborn enrollment are expanding to include Aspen Medical Clinic and Mommy and Me Medical Group.

IEHP appreciates our partnership with our Provider network to ensure that everyone in the Inland Empire has access to the medical care they need.



Early Detection OF COGNITIVE DECLINE

By 2040, the number of Californians over the age of 65 living with Alzheimer's disease may more than double. Additionally, Californians over 65 have a one in five chance of developing a type of dementia. Early cognitive decline detection is crucial so work can begin to slow its progression and improve quality of life for both patients and caregivers.

The Dementia Care Aware (DCA) program is designed to equip primary care providers in California with the tools and knowledge to confidently administer cognitive health assessments.

Led by the California Department of Health Care Services (DHCS) and UC San Francisco, DCA is a training and support program that offers a 5 to 10-minute Cognitive Health Assessment screening approach that can be administered during many

types of visits. This screening fulfills the Annual Well Visit cognitive impairment screening requirement. Providers who complete the training, and attest via the DCA attestation process, can receive \$29 for each annual screening of their Medi-Cal patients who don't have Medicare.

Dementia Care Aware provides training on care planning, connecting patients and caregivers to community resources, and implementing dementia detection and care in clinical practice.

Conquering Loneliness and Isolation

MEETING PEOPLE WHERE THEY ARE

Dr. Vivek Murthy, the United States Surgeon General, released an advisory this year on the public health crisis of loneliness, isolation, and the lack of connection within our communities titled *Our Epidemic of Loneliness and Isolation – The U.S. Surgeon General’s Advisory on the Healing Effects of Social Connection and Community*.

Nearly half of American adults report experiencing some level of loneliness. This has been linked to poor mental and physical health outcomes. Social isolation increases the risk of heart disease and stroke by 29% and 32%, respectively, and raises the risk of dementia by 50%. Loneliness is linked to higher rates of depression, anxiety, and suicide.

It's important to recognize the signs of loneliness and social isolation in your patients to assist them in accessing connections in their community. **One option to connect patients with their community is referring patients to IEHP’s Community Resource Centers (CRC).** IEHP’s CRCs located in Riverside, San Bernardino, and Victorville, offer the following classes free of charge to everyone in our community:

- Fitness
- Nutrition
- Meditation
- Stress Management
- Diabetes Management
- Asthma

The CRCs offer opportunities to build in-person relationships with community members and IEHP’s caring team, as was the case for Maria Alvarado, a 92-year-old IEHP Member, who found solace and companionship after the passing of her husband.

If Members express concerns with their mental health, you can fill out a referral to a Behavioral Health Provider on the Provider Portal. You can also direct Members to IEHP Member Services at **1-800-440-4347**, Monday through Friday from 7a.m.-7p.m., and Saturday through Sunday from 8a.m.-5p.m. TTY users can call **1-800-718-4347**. Members can speak to the Behavioral Health Department, who will evaluate the severity of the Member’s mental health needs and direct the Member to appropriate care.

IEHP HEALTHCARE SCHOLARSHIP FUND

Investing in the Future of Healthcare

IEHP is proud to partner with local academic institutions to support the Inland Empire Health Plan (IEHP) Healthcare Scholarship Fund (HSF). This initiative assists local medical students by alleviating the burden of debt, which can discourage aspiring health care professionals from pursuing their dreams. The Inland Empire (I.E.) has one of the lowest ratios of physicians per 100,000 people in California and by awarding scholarships to students, HSF is helping to increase the number of healthcare providers serving the Inland Empire's growing Medi-Cal population.

As of August 2023, we have invested \$8 million and awarded a total of 168 scholarships, with over 30% of the recipients being from the I.E. More than 50% of current HSF recipients are first-generation medical students who grew up in low-income households.

HSF recipients gain access to IEHP's leadership and provider network as a resource in their academic journey. The scholarship has empowered students like Elizabeth Celaya-Ojeda, a four-year award recipient from UC Riverside, to pursue her passion for serving underserved communities.

"I want to work particularly with the underserved in this area because I truly believe that being a physician is a privilege and with that there is a responsibility to be an advocate for those who are facing health disparities. I am particularly interested in providing care to underserved Native American and Hispanic communities. Not many healthcare providers are aware of the disparities these two communities face and I want to be an advocate for them, especially in the Inland Empire," said Ms. Celaya-Ojeda.

Medical students accepted into Loma Linda University Medical School, UC Riverside, and the California University of Science and Medicine are eligible to apply for the scholarship directly through their school. All HSF recipients must commit to practicing medicine in the I.E. for at least five years after graduation.

The HSF is just one of the many ways we are working to make healthcare more accessible and support new physicians in their journey. By investing in the next generation of healthcare providers, we are excited to play a part in helping the region thrive for years to come.

FLU AND COVID VACCINES

Flu season is here, and it can be especially harmful for pregnant Members, children under five, and adults over 65 years of age. Getting the flu vaccine is particularly beneficial during pregnancy, as it helps protect both the mother and the baby from the disease.

Here are Best Practices for Encouraging Flu Shots:

1. Place flu vaccine educational posters in waiting and exam rooms
2. Talk to parents personally to address their concerns about vaccinating their children for the flu and provide important information when they are hesitant to get their children the flu vaccine.
3. Encourage Members to receive the new single dose COVID-19 vaccine alongside their flu vaccine.


